NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Reacon Primary Teacher Training Institute, Plot No.- 2908, 2907, St. No.- Irika Road, Will/ P.O.- Goas, Tehsil/ Taluka Islampur, Town/ City Berhampur, Dist Murshldabad, West Bengal 742304 for conducting D.El.Ed. - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 4. The recognition/permission is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.
- 5. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7.  - e) Fee charged from students;
 - ij Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter:
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
